### Use of cookies

This Cookie Policy was updated on September 20, 2020.

#### 1. Introduction

Our website <https://www.kupbilecik.pl/> (hereinafter: the "website") uses cookies and other related technologies (for convenience, all technologies are referred to as "cookies"). Cookies are also placed by third parties we have engaged. In the document below, we inform you about the use of cookies on our website.

#### 2. What are cookies??

A cookie is a small, simple file that is sent together with the pages of this website and stored by your browser on the hard drive of your computer or other device. The information stored therein may be returned to our servers or to the servers of the relevant third parties during your next visit.

#### 3. What are scripts??

A script is a piece of program code that is used to make our website function correctly and interactively. This code is executed on our server or on your device.

##### 5.1 Technical or functional cookies
